By reserving your vacation and making payment, you thereby agree to the terms and conditions set forth between the Traveler and The Kelli and Gregg Company, LLC.

The term "The Kelli and Gregg Company" shall mean "The Kelli and Gregg Company, LLC" and "KelliGregg Travel" (dba for The Kelli and Gregg Company LLC) and shall include any affiliates, servants, agents, and/or employees in connection with any service related to, arising from or in any way connected with the vacation, including but not limited to all bookings, lodging, transportation, and any activities in connection with the vacation. The term "Traveler" shall mean the party making the reservation as well as all parties, family and/or individuals for whom the reservation is made. The term "Traveler" shall also signify all assignees, subrogees, heirs and successors in interest. In signing this "The Kelli and Gregg Company" contract, Traveler agrees to the following:

KelliGregg Travel acts as an advisor/travel agent for Traveler in arranging the vacation. This includes, but is not limited to, all land transportation, sea travel, air transportation, accommodations, ship services, resort activities, and any other activities arranged by or connected to KelliGregg Travel. You hereby acknowledge and agree that the cruise lines, hotels, resorts, tour operators or transfer companies have full and exclusive control of the resort, vessel, hotel or airplane where your KelliGregg Travel vacation occurs and that the Supplier, not KelliGregg Travel, shall be solely responsible for any and all liability, loss, expense, damages or claims arising out of or related to any act, conduct or omission occurring while you are on board the vessel, the airplane, or within the hotel or resort.

You hereby acknowledge and agree that, in addition to the terms and conditions of this Agreement, you will be bound by the passenger ticket contract and by the general terms and conditions of the Supplier's passenger contract or policy or terms and conditions of the Supplier's "ticket". The ticket and all its definitions, terms and conditions are hereby incorporated into this Agreement by reference.

You hereby agree to hold KelliGregg Travel free of responsibility for and to bear the sole risk of any delay, claim, liability, loss or accident occasioned by the fault or negligence of any Supplier or other person or company entrusted with such service.

In the event of trip interruption, changes or delays or cancellation of your KelliGregg Travel trip for any reason or in the event of default, real or alleged, of any kind by KelliGregg Travel or Supplier, or for whatever reason failed to perform its obligations to you, the sole liability of KelliGregg Travel and the Supplier shall be to refund all monies paid by you for all obligations for which you have not received. KelliGregg Travel shall not be liable to you for any other costs incurred by you including but not limited to travel costs or other costs incurred by you in preparation of your vacation or for any consequential damages arising from, or as a result of, such cancellation.

Bookings / Payments

A deposit of \$500 per person is due at the time of booking. Final payment is due 120 days prior to the vacation.

Cancellation / Refund

This trip has a refundable deposit up until the final payment due date (120 days prior to vacation). After that date, the trip is due in full and non-refundable. We do recommend purchasing travel insurance. (we can assist!)
